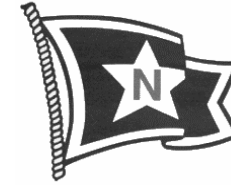

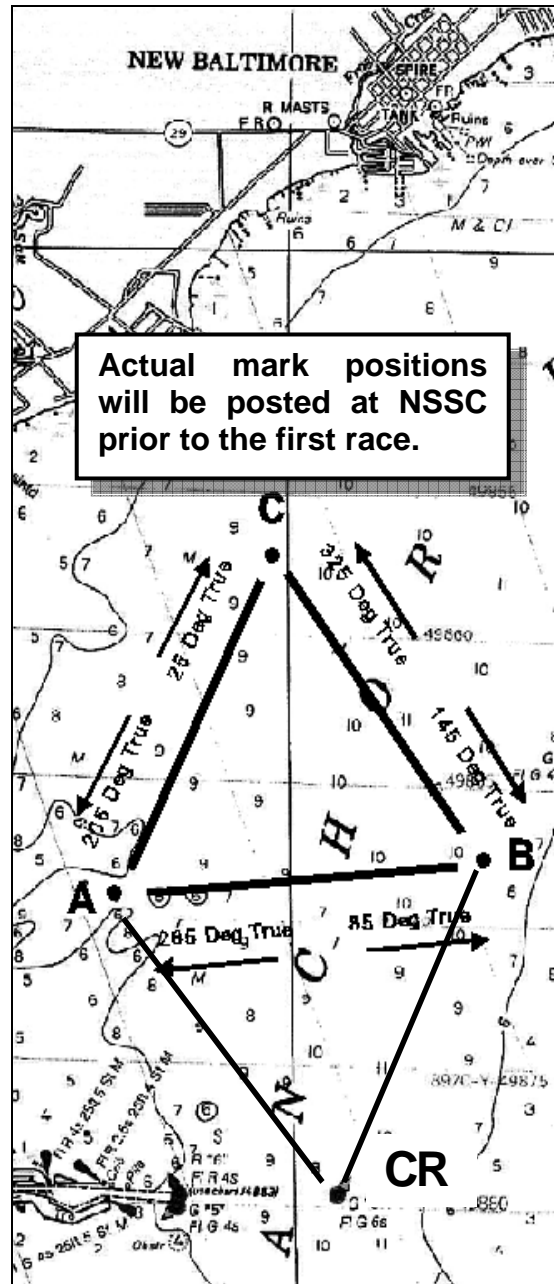
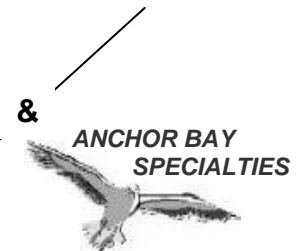

Organizing authority: North Star Sail Club
Rules: The regatta shall be governed by the 2005-2008 Racing Rules of Sailing with United States Sailing prescriptions, class rules and the ABYRA Sailing Instructions.

Eligibility: Races are open to sail yachts owned or chartered by individual members of clubs or associations which are members in good standing of ABYRA, DRYA and/or USSA, and who have paid their race fees. In the event that the registered skipper is unable to be on board, he/she is allowed to have a duly insured alternate skipper to represent him/her in up to two (2) races.

Classes: Spinnaker and JAM classes. Class splits will be posted at NSSC clubhouse 2 hours before the first race. Five boats required for a one-design start

Start Time: The Warning signal for the first class shall be 1900hrs (7:00PM). JAM class boats will start prior to Spinnaker boats.

Registration: Registration shall be submitted on the official entry form with entry fee and rating certificate. Completed entry forms shall be received by 1200 hrs the day before the event and can be mailed to NSSC or deposited in the NSSC drop

slot. Late entries will be accepted and will be subject to a \$5.00 late fee. Make checks out to NSSC.

Sailing Instructions: Sailing instructions will be available at NSSC and NSSC web site (www.northstarsail.org) no later than one week prior to an event. Changes to the Sailing Instructions will be posted at NSSC on the day of the race. It is the responsibility of each competitor to check the Official Notice Board for changes.

Course: Courses will be on the Anchor Bay Triangle. Course selection will be visually communicated to competitors prior to the warning signal. Available course configurations and visual signals are documented in the 2006 ABYRA Handbook.

Awards: Results available at NSSC after each race. Spring awards presented Aug 11th after the race. Summer and Season awards will be presented at the ABYRA Awards Banquet.

Race Committee Duty: All registered boats are responsible for 1 (one) Race Committee duty per ABYRA handbook rules.

Competing yachts shall in all respects be ready for sea and shall be manned by an adequate and capable crew. It shall be the sole and exclusive responsibility of the skipper and crew of the yacht to decide whether to start or not to start, to continue or to finish a race. The skipper must assure that all required United States Coast Guard equipment, as well as other necessary safety equipment, is aboard, properly maintained and stowed, and that the crew knows where it is kept and how it is used.
