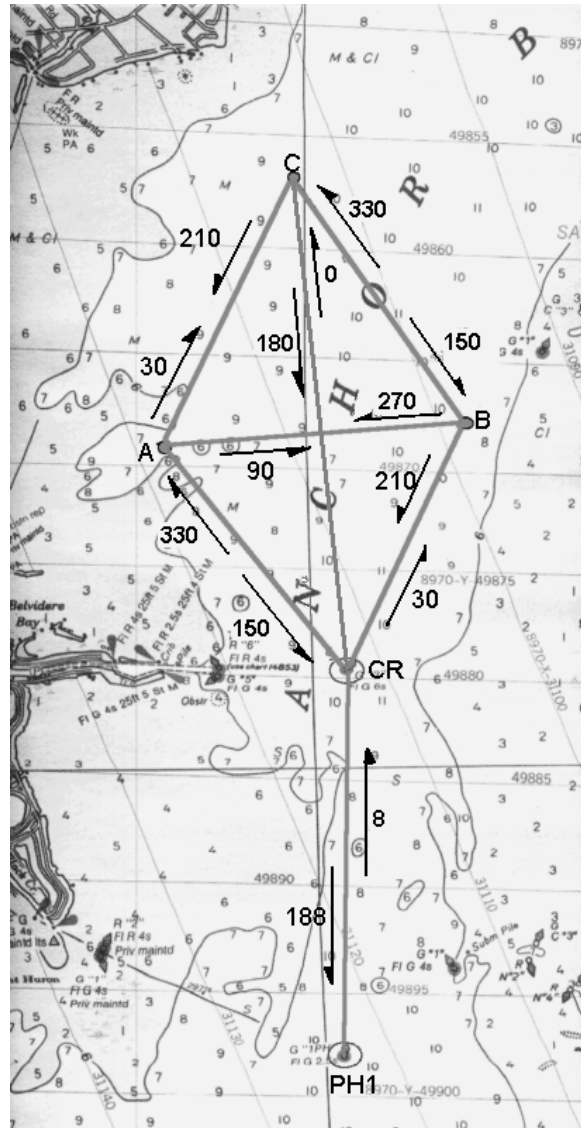

Spring Series:

Summer Series:

Rules: This race will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS) and as modified by the 2010 Anchor Bay Yacht Racing Association (ABYRA) Handbook, this Notice of Race, and the Sailing Instructions for this race.

Management: North Star Sail Club is the organizing authority and will provide race management.

Classes: JAM, Asymmetrical, and Spinnaker classes. Class splits will be posted at NSSC clubhouse no later than 2 hours before the race. Five boats are required for a one-design or double-handed start. JAM class boats will start prior to Spinnaker boats.

Scoring: Races will be scored using order of finish for one-design classes and time-on-time over PHRF for other classes and division overall. See 2010 ABYRA Handbook for series scoring rules.

Eligibility: Races are open to sail yachts owned or chartered by individual members of clubs or associations which are members in good standing of ABYRA, DRYA, or US Sailing, and who have paid their race fees. In the event that the registered skipper is unable to be on board, he/she is allowed to have a duly insured alternate skipper to represent him/her in up to two (2) races.

Registration: Registration shall be submitted on this official entry form with entry fee and rating certificate. Completed entry forms shall be received by 1200 the day before the event and can be mailed to NSSC or deposited in the NSSC drop slot. Late entries will be accepted and will be subject to a \$5.00 late fee. Make checks out to NSSC.

Sailing Instructions: Sailing instructions will be available at NSSC and NSSC web site (www.northstarsail.org) no later than one week prior to an event. Changes to the Sailing Instructions will be posted at NSSC by 1700 on the day of the race. It is the responsibility of each competitor to check the Official Notice Board for changes.

Course: Courses will be on the Anchor Bay Triangle. Course selection will be visually communicated to competitors prior to the warning signal. Available course configurations and visual signals are described in the 2010 ABYRA Handbook.

Awards: Results available at NSSC after each race. Spring awards presented Aug 6 after the race. Summer and Season awards will be presented at the ABYRA Haul Out Party & Awards Banquet.

Race Committee Duty: All registered boats are responsible for 1 (one) race committee duty per ABYRA handbook rules.
