FEES

Senior Membership - Family & Individual

- Application Fee - **\$25** (Non-refundable)
- Initiation Fee - **\$800**

- Annual dues - **\$800**

(The first years total of \$1,800 may be paid in 4 payments spread over one membership year)

Intermediate Membership

- Initiation Fee - **\$50** (non-refundable)
- Certificate of Indebtedness - **\$200**
- Annual Dues - **\$240**

(Intermediate members moving to Senior membership may apply their initiation fee of \$50 towards the first years cost of their Senior initiation fee)

Junior Membership

- Initiation Fee
14 - 18 is **\$25**
19 - 26 is **\$50**
- Annual Dues - **\$25**

(Junior members moving to Intermediate or Senior membership may apply their dues paid up to \$200 towards the first year's cost of membership initiation fees)
