- Annual Dues - **\$335**

### Senior Membership - Family & Individual

- Application Fee - **\$25** (Non-refundable)
- Initiation Fee - **\$800**
- Certificate of Indebtedness - **\$200**
- Annual dues - **\$600**

*(The first years total of \$1,600 may be paid in 4 payments spread over one membership year.)*

## COMMITMENTS

- 12 work hours per calendar year (October 1 to September 30).
- 6 hours for Junior Members
- 24 work hours for Intermediate Members
- 4 of 12 work hours must be at a work day or a social event.
- Non-completed work hours are billed **\$25** per hour not worked. (**\$7** per hour for Junior Members)
